## **Call for Posters:**

All scientific topics relating to inhalation toxicology are welcome. You will need to register and pay as a delegate if you plan to attend with your poster (the delegate fees are detailed later). if you would like to bring a poster with you then please let the AIT know at <a href="mailto:aitoxicology@gmail.com">aitoxicology@gmail.com</a> as soon as possible to allow the AIT committee to accept the poster submission.

# Scientific Agenda:

The 2023 scientific agenda will include the following (there may be slight changes):

- 1. Day 1 sessions will focus on **in-vitro inhalation**.
- 2. Day 2 sessions will focus on inhaled cannabinoids, juvenile animal inhaled data and there will be a short AIT AGM meeting.
- 3. Day 3 (approximately 09:00 to ~14:00) will focus on AstraZeneca (AZ) Inhalation and Innovations plus a tour of AZ is being planned. You will also have an opportunity to ask the poster presenters any questions that you may have, see what the exhibitors are promoting and have the time for networking.
  - The tour of AstraZeneca will be either "The Amazing Journey" or a "tour of the inhalation facility" (TBC). The tour is in the planning process. Delegates will be taken on the tour in groups. Registration for the tour at the various time slots during the morning will be essential to secure your place. Full details to follow.
  - There will be presentations in the auditorium from AZ scientists (one on the toxicology of an inhaled compound and others on AZ inhalation capabilities).
  - Posters will be manned for questions.
  - Time to meet the exhibitors and time to network.

## **NEW OPPORTUNITY 2023: AIT BURSARY:**

There is one bursary available of £500 to help towards the cost of travel and registration to attend the AIT spring conference 2023. In addition, if the successful applicant is not already a member of the AIT, they will also receive 3 years free membership of the AIT to enable them to access previous conference documents and webinar recordings held in the members area of the AIT website.

Applications are welcome at any time from interested members and non-members of the AIT. The awarding of funding will be at the discretion of the AIT Committee.

Priority will be given to individuals working within an "early career" environment, for example, MSc/PhD students, researchers studying/working within a relevant scientific field, or technicians at a recognised institution working towards a professional qualification or gaining more experience within the field of inhalation toxicology.

All applications must be made by email to the AIT at <u>aitoxicology@gmail.com</u>. Applications will be assessed by the AIT committee on merit.

#### Criteria for application:

- 1. The applicant must submit a brief description of the relevance of the meeting to their training or career needs and provide the following information:
  - A brief CV.
  - A letter of recommendation from a supervisor or senior colleague (in lieu of recommendation from an AIT member, if unavailable).
  - Details of alternative funding that they will receive for the meeting (the bursary will be paid following completion of the conference).
  - Up to 3 suggestions for future educational activities/topics that would be helpful to their training.
  - If applicable, a poster abstract.
- 2. Following the meeting and prior to receipt of the bursary funds the successful applicants must submit:
  - A short article (approximately 500 words) describing their own research, a brief overview of the meeting, or a description of how the meeting has contributed to their training/professional knowledge (this may appear in the members-only section of the AIT website).
  - An expense claim including receipts for expenses incurred in relation to the meeting (travel/registration).
- 3. By applying for the bursary, all applicants consent to their details being added to the AIT mailing list and will automatically receive information on other events when it becomes available. Details will not be passed on to any other organisation without written permission.
